### MANIFESTO:

1. MY EXPRESS CONSENT AND AUTHORIZATION to the fact that my child, guardian, whose data has been reviewed, can play, participate and make use of Children's Paintball in the facilities of COSTA BRAVA PARC AVENTURA and of the material: type of marker or others such as masks, protections, etc. that will be supplied to make use of these. Likewise, I declare to know what the activity of Children's paintball.
2. If for some reason (illness, expulsion, personal request) my child, under tutelage, were to leave the activity, I undertake to take care of him within a maximum period of 1 hour from that the incident be communicated to me by telephone. If I am unable to do so, I undertake to send a person of legal age, expressly authorized, to take charge of my child, guardian in my place.
3. Know the rules of mandatory compliance for participating players that have been provided to me together with this authorization (see page 2,3 and 4) and I undertake to review them / teach them to my child, guardian /da, despite knowing that he will be instructed again by the monitors of the company organizing the game.
4. That I am aware of the risks involved in the participation of my child, under guardianship, in the Paintball field and of the possibility of suffering an accident, which is why I absolve COSTA BRAVA PARC AVENTURA of any responsibility for damages physical and/or material that may suffer during the activity due to fortuitous incidents, own accidents and/or those of other participants.
5. I have been warned that if I cause damage to the material I use or those of other users, the company can make me pay the amount of the same, losing all the time of the activity I have contracted. Failure to do so will result in the user being excluded from the activity.

6. I have been warned that Children's Paintball is an activity that involves significant physical exercise and for this reason, it is highly recommended that my child, under guardianship, have previously completed a medical stress test and consult a doctor. People at risk of heart and/or health problems in general CANNOT do the activity.
7. I have informed my child, guardian, that the lack of respect towards one of the workers of the company, will be grounds for expulsion without any refund.
